- Shows will receive an invoice for Affiliation Fees by the end of January. The affiliation fees each Show pays is calculated at the current rate of \$55 per \$1000 of the 2023 reported gate take. This is the 4th year of this rate as the current Affiliation fee rate has been on hold for the previous 3 years due to COVID. The Board decided to hold the rate to support Shows.
- ❖ In October all Shows were emailed a Show Survey. This survey will provide more information on our Queensland Shows and allow Qld Ag Shows to build a stronger network and provide information relevant to our Shows. If you have not already returned your survey, please do so as soon as possible.

Changes to Queensland Societies reporting requirements - ATO

Not-for-profits (NFPs), including sporting clubs, societies, and associations, with an active Australian Business Number (ABN) need to lodge an annual NFP self-review return to continue accessing income tax exemption.

The NFP self-review return will guide you to consider your sporting organisation's purpose and activities against the requirements of an Eligible income tax exempt entity.

You need to lodge your first NFP self-review return for the 2023–24 income year, between 1 July and 31 October 2024. If your organisation has its own ABN, you'll need to complete your own NFP self-review return even if it's affiliated with a broader sporting group.

To prepare your society or association for lodgement, the person responsible for the organisation will need to:

- check your organisation has an active ABN.
- Notify the ATO if the organisation's address and responsible persons' details need to be updated. This will ensure they have access to the account, receive important tax information and can lodge the NFP self-review return.
- Identify your organization's main purpose and its governing documents.
- Complete an early self-review to check your organisation is eligible to be income tax exempt.
- Set up myGovID and Relationship Authorisation Manager (RAM) so you can complete your NFP self-review return in *Online services for business*.

If your organisation doesn't lodge the return, they may become ineligible for an income tax exemption and penalties may apply.

Who does not need to report -

A government entity or a charity registered with the *Australian Charities and Not-for-profits Commission* (ACNC) are not required to lodge an *NFP self-review return*. Charities already lodge an annual information statement to the ACNC each year.

Similarly taxable not-for-profits are not required to lodge, as they already lodge an income tax return or notify us of a return not necessary each year.

Annual reporting is central to providing the community an assurance that only eligible not-for-profits access an income tax exemption.

Queensland Ag Shows Next Generation was established in 2008 and is the Queensland Chamber of Agricultural Societies youth steering committee.

Comprising up to 11 members, the committee aims to strengthen the Queensland Shows movement by increasing youth participation within local show societies, creating stronger, sustainable events.

Any member of a local Queensland Show between 18 and 35-years-old is automatically a Next Generation member.

Committee members attend their local shows, sub-chamber finals and support the Queensland Ag Shows Board by attending general meetings and assisting with state finals at the Ekka. Expressions of interest are being sought for committee members. Sub Chambers can nominate a young person to represent their Sub Chamber. Nominations must be in by 31st January. If you are interested please contact your Sub Chamber to discuss.

Nominees must be able to attend the Next Gen committee meeting, AGM, and Gala Dinner 16th March. Accommodation will be arranged, and transport costs will be provided.

The Blue Ribbon Cookbook - expression of interest

It will bring together the personal stories of passionate home cooks and capture the spirit of the shows they love. 

However, show societies will also be able to acquire copies at wholesale prices to on-sell them as a fundraiser, use as prizes or to promote their shows.

Waiver Forms and Incident Reports

<u>Waiver Forms</u> are written agreements that say the sponsor of an activity will not be liable for harm suffered by participants. Although waivers are primarily legal tools, they also serve an educational purpose by making people think about the potential risks of an activity.

However, waiver forms may be useful for other activities within our show day programs. Do you have a pavilion which has entries which may be of high monetary value which may have the potential, unfortunately, of getting dirty or damaged. Is it worth considering the competitor filling out a waiver form?

Show Society's may have their own Report Forms; however, Qld Ag Shows have a **General Insurance All in one Waiver 2023** template which can be used. You will find this in the Resource section of Qld AG Shows Website or just follow this link.

An <u>Incident Report Form</u> is a report or record that documents an injury or accident, near miss of an accident, or damage to property. An incident form should be filled out no matter how minor the injury or damage is.

Incident Report Forms must be kept on record for a minimum of 5 years. A copy must be sent to the Qld Ag Shows office and your insurance company/broker. Shows in the group insurance scheme need to send these forms to Bron Henty-Smith at Gallaghers. A blank form should be in your first aid kit and would be

worth having in your competitions box at each event on show day.

All members must be aware to notify their Show Office immediately if an incident occurs which has resulted in Injury, illness or death to people or animals or damage or destruction of property at your event and that a report has been completed.
